Along with these developments, as Minister and the Chair of the National Digital Switchover Steering Committee, I will shortly be forwarding for Cabinet consideration, the recommendations from that Committee.

I wish to thank the members of the Commission for their able support and invaluable contribution. The Committee was Co-chaired by Professor Hopeton Dunn, Mr. Lester Spaulding and Mrs. Winsome Witter all of whom led discussions with respect to DSO considerations for the broadcasting and cable industries.

Once again, it is my great pleasure to welcome you to this Conference, and particularly those who have traveled to our shores to share in this rich experience.

I do trust that amid the hard work, you will find some time to enjoy the warmth, beauty and hospitality of our island and our people.
